WEBSITE TERMS OF USE

The following terms and conditions (the “Terms”) govern all use of the Horizon 3 AI, Inc. (“Horizon 3 AI”) website located at <https://www.horizon3.ai> including any subdomains (collectively the “Site”). The Site is owned and operated by Horizon 3 AI. BY USING OR ACCESSING ANY PART OF THE SITE, YOU AGREE TO ALL OF THE TERMS AND CONDITIONS CONTAINED HEREIN; IF YOU DO NOT AGREE, DO NOT USE OR ACCESS THE SITE.

Horizon 3 AI reserves the right, at its sole discretion, to modify or replace any part of these Terms at any time. It is your responsibility to check these Terms periodically for changes. Your continued use of the Site following the posting of any changes to these Terms constitutes acceptance of those changes.

1. ACCESS.

Subject to these Terms, the Site is made available solely for your personal and informational use. Horizon 3 AI may, at any time and in its sole discretion, modify, suspend, restrict, or discontinue the Site or any portion thereof, including the availability of any feature, content, or functionality, without notice or liability.
